Brief Description of Works: Construction of 8 (eight) Grain Silos at Chittagong (114,300 MT), Maheshwarpasha, Khulna (76,200 MT), Dhaka (48,000 MT), Narayangani (48,000 MT), Barisal (48,000 MT), Madupur (48,000 MT), Mymensingh (48,000 MT) and Ashugonj (105,000 MT) with all ancillary facilities, public toilet, vehicle parking, water supply, sewerage, surface drain, equipment, machineries and firefighting.

This invitation for prequalification follows the general procurement notice for this project that appeared in Development Business No. WB54-01/15 of 6 January 2015 on-line.

The People's Republic of Bangladesh has received a credit from the International Development Association (IDA) toward the cost of the Modern Food Storage Facilities Project (MFSP), and it intends to apply part of the proceeds of this credit to payments for construction of steel silos.

The Directorate General of Food intends to prequalify contractors and/or firms for

W-3	Construction of the Rice Silos in Madhupur (48,000 MT), Mymensingh (48,000 MT) and Ashuganj (105,000 MT) with all ancillary facilities, public toilet, vehicle parking, water supply, sewerage, surface drain, equipment, machineries and fire fighting.

It is expected that invitations for bid will be made in August 2016. Applications may be made for prequalification for one or more of the contracts.

Prequalification will be conducted through prequalification procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, January 2011, and is open to all bidders from eligible source countries, as defined in the guidelines.

Interested eligible Applicants may obtain further information from and inspect the prequalification document at the address below from 1000 to 1600 hours. A complete set of the prequalification document in English may be purchased by interested Applicants on the submission of a written application to the address below and upon payment of a nonrefundable fee of cash BDT 5,000.00. The document will be delivered by hand.

Applications for prequalification should be submitted in sealed envelopes, delivered to the address below by 14 March 2016 Time 1300 hours local time, and be clearly marked "Application to Prequalify for <insert name of package>."

Pre-Application Meeting will be held on 15 February 2016 at 11:00 am at PMU Office.

Applicants shall be considered to have a conflict of interest, if they participated as a consultant in the preparation of the design or technical specifications or have been hired or proposed to be hired by the Employer or Borrower as Engineer for contract implementation of the works that are the subject of this prequalification.
