**Assignment Title: Consulting Firm for Overseas Study Tour and Training Program.**

**Request for Expression of Interest (EOI) for selecting a Consulting Firm for Overseas Study Tour and Training Program.**

1. Government of The People's Republic of Bangladesh has received an IDA credit toward the costs of the Modern Food Storage Facilities Project (MFSP), being implemented by the Directorate General of Food, Ministry of Food and intends to apply part of the proceeds to payments for the consultancy services.
2. Brief description of the assignment are:
  - a. Visit to factories to oversee the manufacturing process of silo electro-mechanical equipment for 15 technical persons (Silo Related) in Italy and Spain, 09 (nine) days.
  - b. 15-days foreign training on maintenance and operation of the plant for 16 technical persons (Silo Related) in Adani Logistics and Kohinoor Food Limited of India.
  - c. Study tour (5 batches, 7 in each batch, for 7 days) to countries where steel rice silos are operated (Among others, candidates would be selected from concerned sector of Planning Com/ERD/IMED/MoF) (Silo Related) in Vietnam or Turkey.
3. **Duration of service:** The service is expected to run over 2 years.
4. **Shortlisting criteria :** EOIs would be reviewed on the basis of the following criteria
  - a. Registration details of the Firm
  - b. Evidence of successful implementation of overseas training/study tour program(s) for government and development partner.
  - c. Evidence of permanent office in Dhaka. Having overseas office facilities will be preferred.
  - d. Global Network: Regional/Global Network with other International training organization/Institute/University. The intending firms need to submit documentary evidence of partnership agreement.
5. **Selection Procedures:** The consulting firm will be selected through **QUALITY and COST BASED SELECTION (QCBS)** procedure of World Bank Guidelines for Selection and Employment of Consultants under IDA Credits & Grants by World Bank Borrowers updated January 2011.
6. Last date and time for submission of Expression of Interest (hard copy) is **2:00 pm 07 February, 2016.**
