Minimum 5 (five) years' experience in ICT business as a registered company/entity in Bangladesh 2. Must submit updated Trade license, Income tax and VAT certificate. 3. Must have 5 (five) years practical experience of developing web-based enterprise solution and 2(two) years practical experience of developing Mobile Apps with similar technology having features related to this system as major or partner solution provider. 4. Must have experience of developing software solution for Government of Bangladesh. 5. Must have 2 years experience in working with international donor agency such as Food and Agriculture Organization of the United Nations (FAO), Access to information (a2i), United Nations Development Programme (UNDP), and World Bank. 6. Companies having experience of working with software solution development related to public service delivery in relevant area will be an added quality. 7. Must have experience in developing web-based application implemented having data of about 20GB and concurrent user of 5,000 and above. 8. Vendor needs to have at least three existing running software solution in Government of Bangladesh and at least three existing running software solution also in any large private Sector in File Management/MIS/decision management/Data Management/Workflow Management/ERP. 9. Needs to have full time experienced human resource in business analysis, system analysis and design, software development (Web and Mobile), database management, project management and in support management. 10.
